INICIOS 1.2.3 Language Learning Center continue to follow our existing stringent health and safety protocols, including:

- ✓ Requiring any children or staff with respiratory illness symptoms or fever to return home and stay home until fever free for at least 24 hours.
- ✓ Frequent disinfecting and sanitizing of high-touch toys and surfaces.
- ✓ Frequent handwashing by children and staff, which is embedded in our curriculum and daily staff protocols.
- ✓ Training teachers on common signs of illness in children, and placing signage in the classroom to keep signs of illness top of mind.
- ✓ Maintaining an up-to-date and customized Safe School Plan posted in the classroom for easy access.
- ✓ Inicios 1.2.3 Language Learning Center have implemented enhanced procedures to limit the spread of Covid-19 and/or other sickness and is frequently communicating with families and staff to convey the enhanced measures in place within their Spanish Program.

Health and Safety protocols include:

- ✓ Limiting the people who enter the building to current team members and *Preschool* students ONLY.
- ✓ Touchless check-in
- ✓ External drop-off and pick-up of children. A member from our staff will meet you at the door. When you come to pick up later in the day, please remain outside, let the front desk know who you are picking up and one staff member will bring your child to you, please have your ID ready when doing so.
- ✓ Increased frequency of hand washing.
- ✓ Increased sanitation of frequently touched surfaces and toys
- ✓ Limiting use of materials and toys equipment to one child at a time and disinfecting before and after each use.
- ✓ Students will not share water, food or educational material, each student will have his/her own material.
- ✓ Each student will have an individual mat to sit on, the mat will be washed and dissinfected every day.
- ✓ Inicios1.2.3 Covid-19 Acknowledgement and Waiver of Risk and Liability needs to be signed.
- ✓ Please note that we currently live in constant change and although we cannot control everything, our commitment is to keep you informed of any changes as son as posible.



Inicios 1.2.3 Language Learning Center COVID-19 Acknowledgement and Waiver of Risk and Liability

In light of the ongoing COVID-19 pandemic, Inicios 1.2.3 Language Learning Center is committed to adhering to all regulations, recommendations, and guidelines put forth by the Centers For Disease Control (CDC) the State of Tennessee & the Knox County Health Department. With careful consideration of "return to IN-PERSON lessons" policies is providing this document to ensure that all parents acknowledge and accept the risks.

At this time, Inicios 1.2.3 Language Learning Center encourages all students and parents to follow basic health guidelines, including—but not limited to—the following: washing hands and using hand sanitizer regularly; minimizing touching of the face with the hands; maintenance of six-feet of "social distancing" whenever possible; limiting close-contact interaction with others before and after our Bilingual Preschool activities.

Inicios 1.2.3 Language Learning Center mandates that any student who shows a temperature of 100 degrees Fahrenheit or higher -- and any student who shows any other signs of illness, including, but not limited to, runny nose, prolonged coughing, or chills -- must be withheld from our Program activities until symptoms subside. Furthermore, any student who tests positive for COVID-19 must be withheld from our Bilingual Preschool activities until they are cleared to partake by a medical professional, as evidenced through written documentation of clearance provided by said medical professional.

Overall, Inicios 1.2.3 Language Learning Center asks all parents to acknowledge that during our Preschool Program, it is impossible for any of us to entirely eliminate the risk that a student, parent or other family member could have contact with individuals who have been exposed to -- and/or diagnosed with -- one or more communicable diseases, including COVID-19. Moreover, it is impossible for any of us to eliminate the risk that, during our Program a student, parent or other family member could become infected through contact with, or close proximity to, an individual with a communicable disease, including COVID-19. By signing this document, you acknowledge an awareness and understanding of these risks -- risks that could include prolonged hospitalization, permanent disability, or death from COVID-19 and its correlated complications.

Ultimately, in regard to our Bilingual Preschool Program-controlled activities, students and parents agree to assume all risks, both known and unknown, stemming from COVID-19 and any other related or unrelated communicable illness.
